Dear fellow citizens of St. James Parish,

Welcome to our annual report. In this issue, you will find summaries of a few of the many activities of your sheriff's office as we work to keep our parish safe.

When I'm out in the community, I'm often approached by citizens with concerns and questions. I welcome these opportunities. In an effort to address some of the more frequently asked questions, here are some answers.

I know that 4-wheelers and golf carts are a concern. I'm often asked if we don't have better things to do than chase children "of all ages" around. We would prefer to be responding to situations requiring our urgent attention, but, we will not ignore requests from law-abiding citizens to address the issue of unlicensed and non-permitted vehicles and drivers on 4-wheelers and golf carts. It is illegal to operate these vehicles on parish or state roads unless they have the proper equipment required by state law. Contact us for information on what you need to do to make these vehicles "street legal."

Not only is texting while driving illegal, it is also an extremely dangerous practice that has caused numerous accidents. Law enforcement officers will cite drivers for this violation.

Many people would argue that cell phones are out of control. They could also make a good case that distracted drivers are very dangerous drivers. But, we still have the right to use cell phones while driving in Louisiana. We should all use good judgment as to when and how we use our phones so we don't end up with laws limiting their use while operating a vehicle.

You can and should dial 9-1-1 to report any unusual activity. Use it if you suspect a driver of being drunk or a road menace. Use it if you see a young child left in an unattended vehicle who may be in danger from excessive heat. Call us if you see anything that looks even the least bit out of the ordinary.

It's part of our mission to keep the community informed of and involved in our activities. Let us know if your group would like a speaker from our department for your next meeting or if you would like a tour of our operation.


Vsigner

Acquiring a warrant in St. James Parish for a search, arrest, release order or preset bond used to take anywhere from three to five hours. These days, thanks to a new, web-based electronic system, it takes about 17 minutes.

Vsigner allows a deputy to type up a warrant and E-mail it to a judge who can approve it by attaching an electronic signature and e-mailing it back. Formerly, warrants had to be written, taken to judges and then brought back to the scene of an investigation.

"Vsigner saves us valuable time and it can be a great aid in investigations," Sheriff Martin said. "If a deputy carrying out a warrant sees evidence of another crime, he can get another warrant without leaving the premises. We can make stronger cases against criminals who commit multiple crimes and free up personnel to perform other duties."

Besides law enforcement agencies, Vsigner is used by district attorneys, clerks of court, justices of the peace and parish/municipal governments.



Vehicle Tracking System

New technology allows the SJPSO to respond even more quickly to your call for assistance as sheriff's office vehicles are now equipped with an AVL - Automated Vehicle Locator. The device provides vehicle location to 911 operators, allowing them to dispatch the deputy closest to a request for help.

"These AVLs allow us to pinpoint where our vehicles are at all times and to send the right type of help to a particular call," Sheriff Martin said. "Our response times will decrease as dispatchers automatically see a display of available units when a call for assistance comes in."

Besides location, AVLs provide data on unit speed, distance covered in a certain time period and information to help schedule regular vehicle maintenance. In



the event a deputy is involved in an accident and cannot call for help, the AVL will provide that unit's location.

"We can tell exactly what areas are being patrolled, when they are being patrolled and when units are inactive," Sheriff Martin said. "AVLs will help us get to you faster."



Rape Aggression Defense

It's a simple idea: Everyone has a right to learn to defend themselves, particularly women in situations of imminent or actual assault. That's the basic premise behind R.A.D., or Rape Aggression Defense classes.

Created in 1989, the R.A.D. course begins with instruction in awareness, prevention, risk reduction and risk avoidance. It then progresses to teaching the basics of carefully selected, realistic self-defense tactics by certified instructors, including special techniques for fighting back, attracting help and escaping a threatening situation. Being prepared to deal with an attack can be the best tool to fight off a potential assailant.

Child Safety Seat Check-up

Louisiana law requires every driver who transports a person less than 13 years old to have the child properly secured. The fine for not using an age and/or size-appropriate passenger restraint system is \$170.50.

The SJPSO recently held a Child Safety Seat Check-up to help motorists ensure that the restraints they are using are safe and installed correctly.

With dozens of child safety seats on the market, it's vital that the one you use is installed correctly. If you would like to arrange for a free examination of your safety seat, please telephone us at 225-562-2374 and make an appointment with Sergeant Anthony Joseph or Deputy Dustin Poché.

Automobile accidents are the number one cause of death for children more than six months old. The simplest and most effective thing anyone can do to protect a young child in an automobile is to properly use the restraints.
