Before I go any further, please allow me to ask you one simple question:

Are you ready, willing and able to help us protect you, your family, home and business from the threat of crime?

I'm certain just about everyone who read that sentence answered "Yes." But will you do more than 'talk the talk' and get involved? When a crime, suspicious activity or public safety incident is reported to our office, we respond as quickly as possible. But all-too-often when we show up, no one is willing to say they witnessed the event or provide evidence that could help us solve the crime or get a conviction. I ask you to 'walk the walk' with us and take a stand against crime.

Speaking of stopping illegal activity, in this issue you'll find articles detailing major upgrades to our crime-fighting technology, ways we give back to the community, a program to protect senior citizens and numerous accomplishments by the law enforcement professionals on our staff. The train derailment and chemical spill in Paulina is also covered. As many areas in our parish continue to recover from Hurricane Ida, we also outline how a generous donation has allowed us to further enhance the emergency response capabilities of our Range/Training Center in Vacherie.

Tech Upgrades

Radio Tracking

We are using new technology to pinpoint the location of a deputy's body-worn radio. During a foot chase or situation where an officer must leave a unit, we know precisely where the incident is taking place and can send assistance if needed.



Body Cams

An upgraded system combines video from dash-mounted and body-worn cameras our deputies have used since 2020. The recordings are stored on one platform, allowing for faster review of an incident. These digital files protect the public as well as our personnel from false claims.

Jail Security

A new, extremely sensitive detector provides deep body scans of anyone entering the parish jail and further limits the introduction of contraband or weapons into the facility.

"This equipment can literally locate a sewing needle in a mattress," Sheriff Martin said. "It enhances the safety of our corrections personnel and inmates."

Safety/Training



Train Derailment/Chemical Spill

An early November train derailment that caused a tank car to spill hazardous material forced the overnight evacuation of about 200 homes in the River Road area of Paulina.

"We responded as quickly as possible, closing streets and sending deputies door-to-door to alert residents and assist them as they left," Sheriff Martin said. "Most people were able to return home a day and a half later."

Parish and state officials will monitor the area to ensure there are no long-term environmental issues.

Hunter/Boater Safety Classes

Louisiana law requires boat operators born after January 1, 1984, to complete a safety class before operating a watercraft with more than a 10 horsepower engine. Hunters born on or after September 1, 1969, must take a safety course before heading to the woods.

Mosaic Grant

As further proof of the outstanding relationship between local government and industry, Mosaic recently provided our office with \$100,000 to purchase a new generator for our Range/Training Center in Vacherie.

"Having uninterrupted power at this facility is vital as it is a staging area during public emergencies," Sheriff Martin said. "By continuing to enhance our capabilities at this site, we are better positioned to assist residents when needed."

During Hurricane Ida, the center served as a distribution point for food, water, tarps and other supplies. It also housed visiting emergency responders and debris removal teams.

Looking Out for Seniors

The SJPSO recently helped host a "Protecting Our Seniors" seminar to help educate our older residents to the many scams that target them, from fake health care offers, to contractor fraud to made-up COVID-19 cures.

"The National Council on Aging reports that nearly \$2 billion was swindled from seniors in 2021," Sheriff Martin said. "These criminals target older people as they are often more vulnerable to these claims. If you have any doubt about a text, phone call or email you receive, contact our office immediately."

Do not give an anonymous person any personal information such as social security, bank account or credit/debit card numbers.

Helping the Less Fortunate
